We utilise data to enable us to understand your informational and support needs – this allows us to develop, maintain and focus our services and for audit /internal record keeping.

We will hold your information for as long as is required to continue to provide you with the services you need / request or until you ask us to delete it (in its entirety or select part) / withdraw consent / unsubscribe.

We will not sell, distribute or lease your personal information to any third party without your explicit, written, permission or are required by law to do so.

Controlling your personal information

You may choose to restrict the collection or use of your personal information in the following ways:

Whenever you are asked to fill in a form in person or on the website, you will be advised to read and agree to our privacy policy, before being asked for your consent, before being able to proceed. We operate an "Opt-In" policy – this means that you will be asked to indicate your consent by either ticking a box or signing your agreement.
